This Myron L Company End-User License Agreement ("EULA") is a legal agreement between you (either an individual person or a company, who will be referred to in this EULA as "User") and the Myron L Company for the Myron L Company product that accompanies this EULA, or that is subsequently provided to the User pursuant to further order, including any associated media, printed materials and electronic documentation (collectively, the "U2CI Product"). By installing, copying, downloading, accessing or otherwise using the U2CI Product, User agrees to be bound by the terms of this EULA. If User does not accept and agree to the terms and conditions of this EULA, Myron L Company is unwilling to allow the use of the U2CI Product contained herein to User. In that case do not install, access or use the U2CI Product; instead delete the U2CI Product from your computer or network in whatever form(s) it exists.

Meaning of words used in this EULA

Myron L Company: refers to "The Myron L Company"

User: the individual person or company that is deemed to be the end-user of the U2CI Product under the terms of this EULA.

U2CI Product: means the Myron L Company U2CI Software Application that accompanies this EULA, including any associated media, printed materials and electronic documentation. The U2CI Product also includes any U2CI updates, U2CI version upgrades, U2CI configuration upgrades, add-on components, web services and/or supplements that Myron L Company may provide to User or make available to User after the date User obtains the initial copy of the U2CI Product, to the extent that such items are not accompanied by a separate EULA or terms of use.

Ownership and grant of usage

The U2CI Product is not sold, but comes bundled with the Myron L Company uDock. The U2CI Product is the sole property of Myron L Company and is protected by all applicable intellectual property and contract laws, including but not limited to laws relating to patent, copyright and trademark laws, and by applicable international treaties and trade provisions. Any breach of Myron L Company's rights as the sole owner of the U2CI Product and all intellectual property rights contained therein and in the U2CI Product may subject the offender to civil and criminal penalties, including fine and/or imprisonment.

This EULA grants User the right to: install and use the U2CI Product on any computer the individual or company will be using with the uDock. In no event, however, shall User be permitted to redistribute the U2CI Product, whether for commercial gain or for no gain. Any use in violation of the license shall constitute not only breach of this EULA, but a violation of national and international copyright laws.

User may not distribute the U2CI Product. User may not modify, translate, or make derivative works of this product.
